DESCRIPTION

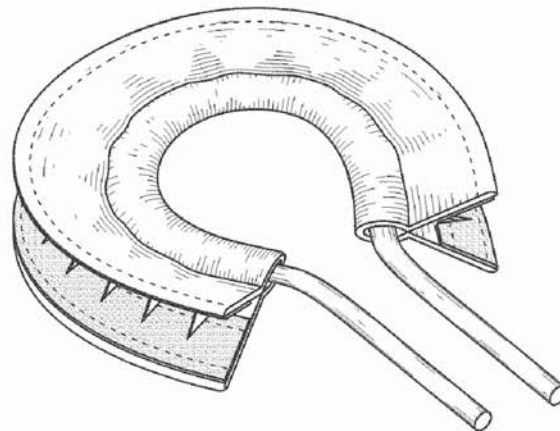
FIG. 1 is a perspective view of a collar component for an Elizabethan cone.
 FIG. 2 is a top or bottom plan view of the collar component of FIG. 1.
 FIG. 3 is a back plan view of the collar component of FIG. 1.
 FIG. 4 is a front plan view of the collar component of FIG. 1.
 FIG. 5 is a left or right side plan view of the collar component of FIG. 1; and,
 FIG. 6 is an environmental view of the collar component of FIG. 1 coupled to an Elizabethan cone.
 The elements in broken line are not claimed.

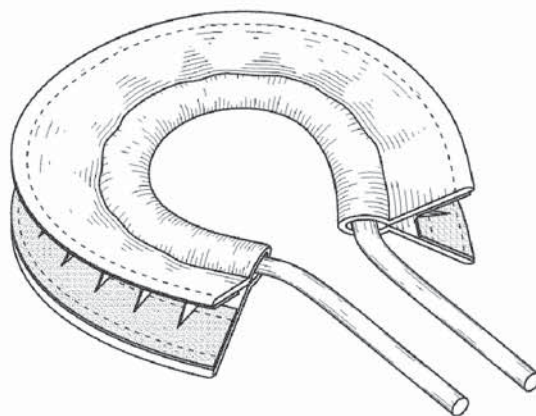

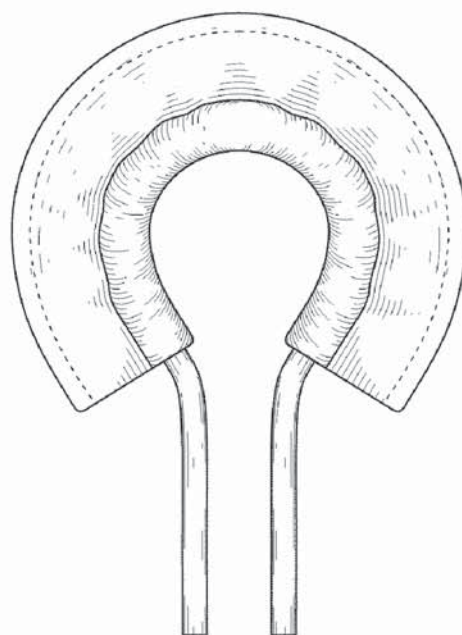

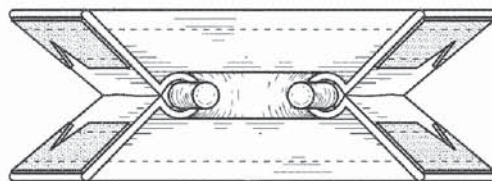

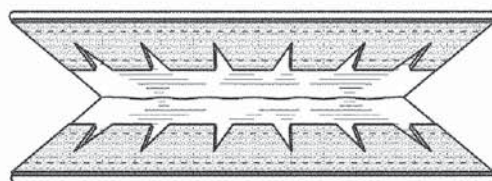

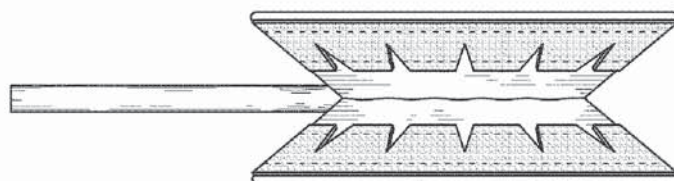

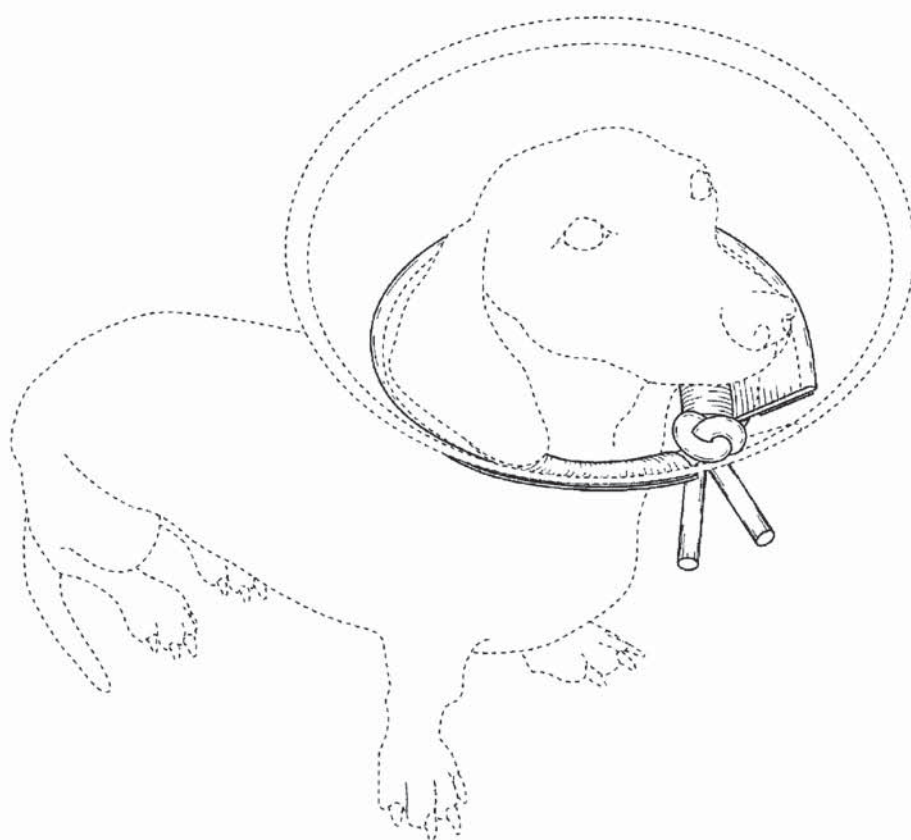
